Job Summary

The **Certified Nurse Aide (Clinic Care Team)** is responsible for working within the clinic care teams including providing nurse aide services and performing lab work for participants assigned to their panel.

Essential Job Functions

- Assist Primary Care Provider and Nurse Case Manager with procedures and room preparation (as needed)
- Perform next day appointment confirmations phone calls for their participant panel.
- Confirm and document in the E.H.R. every scheduled lab confirmation phone call for the next day's schedule.
- Perform confirmation phone calls every Friday for the next week's external participant appointments for their participant panel. (As needed)
- Prepare participant clinical appointment packets for the Primary Care Provider before appointment.
- Verify appropriate specialist notes for Primary Care Provider reference
- Review the previous day's performed labs for results within the E.H.R.
- Performing participant phone calls regarding lab results as directed by the Primary Care Provider
- Perform participant venipuncture's
- Responsible for lab order scheduling.
- Collect and process lab orders, as directed.
- Perform Quality Control (QC) checks on lab equipment daily and as needed and document on Quality Logs for filing.
- Perform finger stick blood testing to participants as ordered. Communicate with outside contractors for participant care coordination as ordered by the Primary Care Provider.
- Assists participants with physical activity, exercise, walking, toileting, showering, eating and grooming.
- Perform participant rooming, collecting vital signs, performing ECGs, non-diabetic foot care
- Ordering and stocking medical supplies within each clinic exam room and the central storage area according to mandatory par levels.
- Sanitize exam rooms after each participant encounter and deep clean each exam room at the end of business day.
- Provides participant behavioral supervision and support.
- Complete required forms and documentation.

- Responsible for participant safety, identifying safety hazards and implementing corrective actions.
- Present participant information and updates to relevant staff members.
- **Maintain strict confidentiality of all participant information.**
- Requires *occasional* use of personal vehicle for business purposes.
- All other duties assigned by the *Chief Nursing Officer*.

Core Job Functions for All Staff

- Attends and participates in staff meetings, in-services, projects and committees as assigned.
- Adheres to and knowledgeable of CEC policies, practices and procedures.
- Accepts assigned duties in a cooperative manner and performs all other related duties as assigned.
- Participates on task groups and committees, including the Quality Improvement Program

Working Conditions/Physical Demands

The working conditions and physical demands described here are representative of those that must be met by an employee to successfully perform the essential functions of this job. Reasonable accommodations may be made to enable individuals with disabilities to perform the essential functions.

Working conditions and physical demands include:

- Ability to walk, sit and stand for extended periods of time.
- Ability to access all areas of the facility throughout the work day.
- Ability to hear, talk, taste and smell.
- Vision ability includes; peripheral, color, long distance, close proximity, depth perception and adjusting levels of focus.
- Ability to lift up to 50 lbs and move people/objects both short and long distances. (Staff are required to obtain assistance when attempting to lift or transfer objects over 50 lbs)
- Ability to move about with reasonable accommodation, reach turn, twist and touch.
- Requires constant hand grasp and finger dexterity; frequent sitting, standing, walking and repetitive leg and arm movements, occasional bending, reaching forward and overhead; squatting and kneeling.
- Ability to communicate verbally with an excellent comprehension of the English language.
- Work environment will fluctuate repeatedly throughout the day. Work is performed both indoors and outdoors in varying weather elements and occasionally inside of a vehicle.
- Working conditions can include exposure to odors, fumes, infections, dust, and dirt; which may be objectionable

Knowledge, Skills and Abilities

- Must have excellent written, oral and interpersonal skills including professional phone etiquette.
- Must have flexibility with work schedule and a high level of personal integrity.
- Must have working knowledge of physical, psychosocial, behavioral and family needs of the elderly.
- Must have knowledge of community health, social service delivery systems and the aging provider network within the service area.

- Must demonstrate on an ongoing basis the ability to develop and maintain good working relationships with co-workers and department heads while retaining strict confidentiality in all aspects of the position.
- Must have strong computer skills including 10key, typing, scanning and emailing while utilizing electronic health records, Microsoft Excel, Outlook and Word.
- Must have experience utilizing office equipment including phone systems, photocopiers and fax machines.
- Must be detail and accuracy oriented and complete tasks in a timely manner.
- Must be a team player with leadership ability.
- Must attend continuing education courses as needed.

Required Education, Licensure, Experience & Health

Education:

- High School Diploma or GED.

Licensure:

- Certified Nurse Aide-Long Term Care Aide (C.N.A.-LTCA) in the State of Oklahoma
- Adult Day Care Aide Certification (ADCA)-must be attained within the first year of employment
- Certificate of Training in Phlebotomy from an accredited institution within Oklahoma
- Current CPR certificate and first aid training
- Current Driver's License.
- Current Vehicle Insurance in compliance with the Cherokee Nation Motor Vehicle Usage and the CEC Transportation Policy and Procedure.
- A motor vehicle report (MVR) will be completed upon selection and then annually throughout employment. MVR must meet Cherokee Nation Risk Management driver eligibility criteria.

Experience:

- Must have 1 year of experience with a frail or elderly population.
- Must have 1 year experience utilizing medical terminology.
- Must have 1 year of home health or long term care experience.
- Must have 1 year experience utilizing electronic health records.
- Must have completed the clinical practicum for the Phlebotomy Certificate

Employee Health:

- Must be cleared of all communicable diseases upon hire and subsequently throughout employment
- Must provide proof of immunizations upon hire and subsequently throughout employment
